## 2.1 IB Program:

- 2.1.1 Grade 9 clubs for extra help, Pre-diploma Grade 9 will be removed.
- 2.1.2 IB program cost is 150 for one certificate and 450 for whole diploma.

#### 2.2 Sports:

- 2.2.1 Soccer Academy New PE teacher is hired for new school year. 1 block each Semester around 56 students attend the academy. The Soccer Academy is showing increased level of excellence. Priority goes to Grade 10 – 12 students. The number of students are capped maximum 56 students, maximum of 2 blocks with 28 students each block. He started in West Vancouver as PE teacher, he has University level of soccer academy experience. He budgeted 6 academy games, increase cost is 750 to 900.
