## 2 Principal's Report – Jennie Bell

Principal Jennie Bell reported enrollment at 1,363 students, with new registrations daily. Many students have high needs, creating service challenges. Staffing is generally stable with a couple of exceptions – Socials and PE. Jennie expressed appreciation for having the same administration team back this year. Financially, the budget is set, and a new computer lab is in place. The Ministry of Education has withdrawn Affordability Funding, which many families relied on. Assistant Superintendent Bruce Cummings will help apply for grants. Grade 9 students participated in a half-day orientation, which was a positive start to the year.
